AGREEMENT

The patron who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

1.1 As used here "ASCA" means the Australian Shepherd Club of America, Inc., its affiliate clubs and each of their members, officers, directors, employees, show chairs, show committees, and agents.

1.2 Exhibitor/owner acknowledges and agrees to abide by the rules and regulations of ASCA governing sanctioned agility trials, and any other rules and regulations appearing in the premium for this event.

1.3 Exhibitor/owner certifies that the entered dog is not a hazard to persons, dogs, or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.

1.4 Exhibitor/owner acknowledges all hazards presented by the event and the event premises, including, but not limited to, the condition of the floors, stairways, halls, lighting, security measures or lack of, electrical appliances, fitting, show rings, parking areas, and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.

1.5 Exhibitor/owner releases ASCA (including ASCA officers, directors, employees, and members), the Brandywine Valley Australian Shepherd Club (including its officers, directors, members, agents, employees and event organizing committee), the Romano 4-H Center, and Flexible Flyers Agility and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, event, or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assumes sole responsibility for, and agree to indemnify and save aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my(our) participation in this event, howsoever such injury, or death may be caused, and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.
