REQUEST FOR INSPECTION AND AGREEMENT

- I am the owner or the agent for the owner of the above-named horse and I hereby request inspection of the horse for:

- I have read and agree to abide by the Rules and Terms of Inspections of the IDHS (Canada).
- I am a member in good standing of the Irish Draught Horse Society of Canada (Membership No. _____) or my membership application is included with this application.
- The candidate horse is registered with or recognized by the IDHS (Canada) as required for it to be eligible for inspection. The horse's registration number is shown above.

- I acknowledge and agree that acceptance of the above-named horse for the requested inspection is subject to the horse's compliance with the rules of eligibility of the IDHS (Canada). I acknowledge and agree that all of the IDHS (Canada)'s requirements for registration and eligibility for inspection including payment of fees must be met in full before the horse will be scheduled for inspection.
- I understand that approval, if granted, may be upon such conditions as the Inspectors and/or the IDHS (Canada) may decide and that the horse will not be considered approved until the conditions are fully satisfied. I agree that in the event that any condition cannot be satisfied, the horse will be considered unapproved.
- I acknowledge and agree that I am voluntarily submitting the candidate horse to the judgment of the Inspectors and I understand that the horse may not be granted approval. I agree that the Inspectors' decision to approve or not to approve the horse, with or without conditions, is FINAL and that I will not dispute it in any manner whatsoever except by an appeal as allowed by the rules of the IDHS (Canada), regardless of my own opinion or beliefs with respect to the horse or other horses.
- I hereby indemnify and waive all rights of action against the Irish Draught Horse Society of Canada and all of its directors, officers and agents for any damage that may occur to me or the above-named horse in connection with my submission of the horse for inspection.

INSPECTION FEES

Stallion for Registered Irish Draught or Approved Irish Draught Sport Horse status	\$400
Mare for Registered Irish Draught, Appendix Irish Draught or Approved Irish Draught Sport Horse status	\$150
Advisory Inspection for animal not over 2 years of age (may be done by video)	\$50
Gelding Inspection for Registered Irish Draught or Approved Irish Draught Sport Horse Gelding status	\$100

Stallion owners are also responsible for the lab costs for the blood test for EVA, the drug screen and the attending veterinary.
