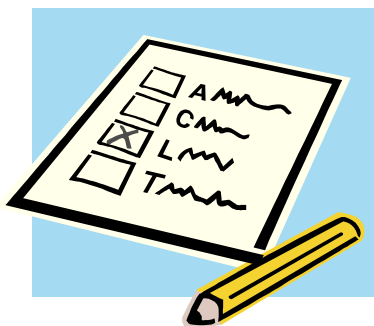
Section 1. Club Year. The Club's fiscal year shall begin on the 1st day of January and end on the last day of December. The club's official year shall begin immediately at the conclusion of the election at the annual meeting and shall continue through the election at the next annual meeting.

Section 2. Annual Meeting. The annual meeting shall be held in the month of May at which Officers and Directors for the ensuing year shall be elected by secret ballot from among those nominated in accordance with Section 4 of this article. If there is only one (1) nominee for each of the Officers and Board positions then election by secret ballot may be dispensed and the Recording Secretary will cast one vote to elect those nominated. They shall take office immediately upon the conclusion of the election and each retiring officer shall turn over to the successor in office all properties and records relating to that office within 30 days after the election.

Section 3. Elections. The nominated candidate receiving the greatest number of votes for each office shall be declared elected.

Section 4. Nominations. No person may be candidate in the Club elections who has not been nominated and is not a voting member in good standing. During the month of February, the Board shall select a Nominating Committee consisting of three (3) members and two (2) alternates, not more than one of who may be a member of the Board. The Correspondence Secretary shall immediately notify the committee members and alternates of their selection. The Board shall name a Chairman for the committee and it shall be such person's duty to call a committee meeting, which shall be held on or before March 15.

a) The committee shall nominate one (1) candidate for each office and positions on the Board, and after securing the consent of each person so nominated, shall immediately report their nominations to the Correspondence Secretary in writing.
b) Upon receipt of the Nominating Committee's report, the Correspondence Secretary shall, at least two weeks before the April meeting, notify each member in writing of the candidates so nominated.
c) Additional nominations may be made at the April meeting by any voting member in attendance provided that the person so nominated does not decline when their name is proposed and provided further that if the proposed candidate is not present at the meeting, the proposer shall present to the Correspondence Secretary a written statement from the proposed candidate signifying willingness to be a candidate. No person may be a candidate for more than one position. Nominations cannot be made at the annual meeting or in any manner other than as provided in this section

APPROVAL OF MINUTES OF LAST MEETING:

There was not a regular meeting in February. It was moved and seconded to approve the January minutes. All approved.

REPORT OF PRESIDENT:

- The club received a letter from the AKC stating that Hollis Land's second place at the specialty was disallowed because the entry was for the wrong class. The parent club is requesting donations for the national – I made the cut, Regional breakfast, trophies, charitable trust or welcome bags. After discussion, it was decided to send items to be included in the welcome bags.

REPORT OF RECORDING SECRETARY:

None.

REPORT OF CORRESPONDING SECRETARY:

The Florida Herding Club wrote requesting donations. No action was taken.

REPORT OF TREASURER:

- Vickie Herring presented a review of the Specialty Show, Banquet and Auctions. Overall, there was a profit of \$3,549.77 – the highest profit since 2007 (when we held a Pat Hastings seminar.) This was influenced by lower judges' expenses than normal. The Specialty Show and Banquet's portion of the profit was \$486.39. The Auctions resulted in a profit of \$3,063.38. The club donated \$747.75 to the Charitable Trust making a total donation to date of \$14,396.53.
- The club has received a letter from the Charitable Trust thanking us for our donation. Membership renewals through Feb. 28 include a total of 70 members (37 regular, 30 associates, 1 junior and 2 honorary.) There are 28 breeder referral listings. The updated membership list will be emailed to Alice, Mark, Wes and Sharon.

REPORTS OF COMMITTEES:

- Show Committee: Next year's specialty will be on Feb. 2, 2012. Paula Ayers asked if the club wanted to use the same hotel again. The consensus was yes. Alice asked for a discussion of the positive and negative aspects of the specialty. The good included – good food, good show setup and takedown, good help with members of a Cavalier Meetup group. Needs improvement includes having a larger ring size for the weekend and better input into the cluster show committee. Kay-C Phipps volunteered to speak with Don Watson if we will remind her.
 - Judges Committee: Shirley Henry will be asked to do sweepstakes next year. Paula said she would have a recommendation for the regular classes judge by the next club meeting.
 - Sunshine Committee: Does anyone know of anyone who is ill?
 - Website Committee: Kay-C Phipps has updated front page events, breeder referral listing, newsletter and meeting information.
 - Newsletter Committee: Alice Alford wants the president to have a chance to review the newsletter before it is sent to the membership.
- Nominating Committee: Kay-C Phipps asked for suggestions. The nominating committee report is due two weeks before the April 5 meeting.

- It was discussed that Sharon Onorato wants to have a certified therapy group under our club. No action was taken
- Alice Alford is working on the AKC Compliance Report. It is due six months before our show.
- There was a discussion about the AKC's Breeder of Merit program.

The Griffin KC has pulled out of the October cluster with the Kennesaw KC, resulting in two days instead of four. The Kennesaw KC still wants our club to do a supported entry of them. After discussion, it was moved and seconded to again support them. All approved. The potential judges include Ann Bolis, Arlene Venko, Ken McDermott and Peggy Hauck. It was decided to ask for Ken McDermott and Loree Isenhauf Gordon and if Loree Isenhauf Gordon does not work, then use Ann Bolis. This was moved and seconded. All approved.

ADJOURNMENT:

It was moved and seconded to adjourn the meeting at 9:00 PM. All approved.

Below is an update on proposed bills in the Georgia General Assembly.

The proposal to tax Veterinary Services is still alive and everyone who lives in Georgia needs to contact their state Representative and tell them that you oppose a tax on Veterinary Services. Therefore, tell them you oppose House Bill 385, House Bill 386, House Bill 387 and House Bill 388. These bills include language that will tax "veterinarian expenses for pets." Remember you are the one that will be paying the 7% to 8% (according to estimates by the Georgia Veterinary Medical Association) increase in your veterinary bill. WE MUST STOP THIS PROPOSAL IN COMMITTEE, IF A TAX BILL REACHES THE HOUSE FLOOR IT WILL BE A STRAIGHT UP AND DOWN VOTE, NO ADMENDMENTS WILL BE ALLOWED. As we stated in the original alert, only three states tax Veterinary Services (Hawaii, South Dakota and New Mexico) and we do not want Georgia to be the fourth. The three bills above total approximately 200 hundred pages and can found at the Georgia General Assembly website if you wish to read them. Sponsors of the bills are Jones of the 46th, O'Neal of the 146th, Peake of the 137, England of the 108th.

If you live in a county that touches the state line, you might want to mention that you would consider crossing the state line to receive Veterinary Services in a state that does not tax. Crossing the state line for services would affect the Georgia economy. You can find out who represents you in the Georgia House of Representatives by going to: <http://www.legis.ga.gov>.

HB 440 which deals with changes to the State Cruelty Law was placed in the House Agriculture and Consumer Affairs Committee. The GCC does not expect this bill to move. Sponsors are Williard of the 49th, Dobbs of the 53rd, Jacobs of the 80th, Golick of the 34, Benfield of the 85th and others.

HB 409 which makes major changes to the State Dangerous and Vicious Dog sections of the Law had a short Judiciary subcommittee hearing Wednesday, March 9, at which time the sponsor stated that he knew the bill would not pass this year and that there were a number of people who opposed the bill. The GCC opposes this bill but has told other stakeholders, including the Sponsor, that we will work with them concerning major changes in this bill. This bill is not expected to move. Sponsors are Maddox of the 172nd, Black of the 174th, Taylor of the 173rd, Battles of the 15th and Atwood of the 179th.

HB 409 This is a bill affecting Veterinarians and Veterinary Technicians. It relates to licensing and registration and seems to be a "housekeeping" bill for the Veterinarians and Veterinary Technicians. The GCC at this point has no concerns with this bill. Sponsor Maddox of the 172nd.

HB 40 "Chiefs Law" would add a bittering agent to antifreeze. Passed the House and had its second reading February 24 in the Senate. Assigned to Senate Special Judiciary. Sponsors are Benton of the 31st, England of the 108, Buckner of the 130th and Kaiser of the 59th. The GCC supports this bill.

HB 60 Service Cancelable Loan, State Veterinarian Board, deals with funding loans for Veterinary students who go into a practice dealing with Food Animals. Sponsors are Maddox of the 172nd and Black of the 174th. Bill passed the house March 8. The GCC supports this bill.

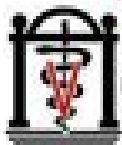

Natural Remedies— Home Made Flea Repellant

With the flea season in our immediate future I thought I would share a wonderful homemade flea repellent recipe with you. I have found this to be a wonderful and very effective and inexpensive formula.

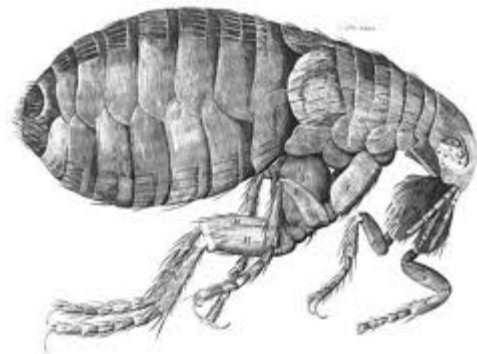
Cut up four lemons and place them in 4 cups of boiling water. Boil for 3 minutes and then let them simmer for an additional 20 minutes more. The real value of this repellent is the oil found in the peel.

Let the mixture cool and then strain through a filter or colander

into a sauce pan. Dispose of the lemons and pulp. From the sauce pan pour the liquid into a measuring cup. From that cup pour the mixture into a clean spray bottle.

Now you have an effective nontoxic flea repellent that you can mist directly on your dog and rub in, or spray on your dog's bed, or your furniture.

Ways To Protect Your Dog's Hearing

The acuity of your family dog's hearing far surpasses that of humans. Hearing is a critical sense to dogs, and when diminished, will increase dependency on the sense of smell. When a dog hears something, he can hear it without moving his head. Many muscles surrounding the ears help dogs get premium sound reception.

Unlike humans, dogs are able to change the position of their outer ear so they can focus on a specific sound. When a dog lifts his ears or turns them, the outer ear allows him to magnify incoming sounds. Dogs with very long ears usually don't hear as well as dogs with smaller ears, floppy ears or triangle shaped ears.

"Contrary to popular belief, dogs cannot hear noises from miles away. Dogs and people hear noises coming from the same distance away," advises Rena Sherwood in *How Does A Dog's Hearing Differ From A Human's*. People hear about 20,000 vibrations of sound per second. Dogs can hear two to five times the number of vibrations!

Animals needed this extensive hearing capability when they lived in the wild. Those living in the wild maintain the acuity just as those living in

our homes.

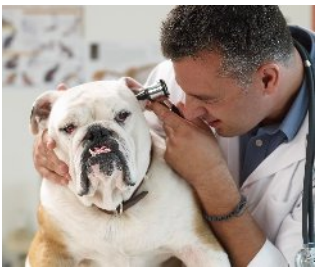
Domestication of dogs as household pets hasn't changed their excellent hearing abilities. Because our dogs seem to hear sounds before we do, they often seem to warn us of impending danger. Heroic stories are often shared about pets saving their owners or family members from fire, earthquake, predators and intruders.

Hearing loss in dogs is caused by many of the same things that cause hearing loss in humans. Hearing loss may be the result of a variety of causes including infection, trauma, noise, aging, drug toxicity and inherited genetic defects. According to the Deaf Dog Education Action Fund, "Hearing loss affecting both ears is called bilateral deafness. A bilaterally deaf dog is completely (or mostly) deaf in both ears. Hearing loss occurring in, or affecting only one ear, is called unilateral deafness. A unilaterally deaf dog has hearing loss in only one ear and has full hearing in the other ear." Laura Derrington advises in *The Structure of Dog Ears*, "Excessive ear wax can cause temporary hearing loss, especially in breeds with narrow ear canals, such as poodles. If a dog has a lot of hair around its ear, the ear canal can get blocked. A foreign object such as a toy or stick that becomes lodged in a dog's ear

also can reduce hearing."

How can we preserve this wondrous hearing capacity our furry family members have? Five tips below will help you ensure your dog's clear, unimpeded hearing:

1. Prevent your pet's exposure to sharp, unexpected noises. This includes loud, repetitive noises that can cause trauma in dogs and humans.
 2. Shield or protect your pet's ears from contributors to noise induced hearing loss (NIHL) including: party noise makers, fireworks, explosive devices, fire and police sirens, hammering, jackhammers, always-on loud music, construction site activities, race car engines, airplane engines, and gunfire.
 3. Have ears checked regularly and cleaned as necessary by your family veterinarian.
 4. Monitor children and toddlers in the dog's presence so that doggie ears (like a child's ears) are not used to stash crayons, marbles, coins or other foreign objects.
 5. Provide well balanced meals containing the nutritional components your vet specifically recommends for your dog's good health and well being.



learned more and more about this precious little breed. My two babies are now big boys, certified in therapy and CGC. That is in part to this club and offering this certification during the Puppy Picnic.

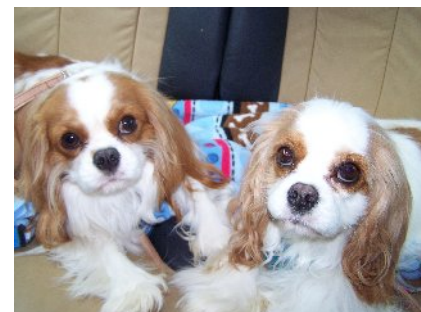
