CONDITIONS OF ENTRY

- 1) I, the undersigned, do hereby agree to the terms and conditions set forth below and so further swear that all information furnished regarding this entry is true and correct to the best of my knowledge, and the Sale Management is not responsible for errors. I agree to have absolute and complete title to entries.
- 2) Sale Management reserves the right to reject any entry. Entry fees will be refunded if animals are rejected.
- 3) I hereby agree that this entry will be reserved for this sale. If this entry is withdrawn for any reason other than medical, with Veterinary certificate, entry fee will be forfeited.
- 4) I do hereby release "Loud & Proud" – Manitoba Paint Horse Breeders, sale management, auctioneers, employees, and representatives thereof, from any and all responsibilities, liabilities, obligations, claims, law suits, or legal proceedings arising from the sale entry and hereby agree to hold the above named parties harmless from any resulting claims actions, liabilities or judgements.
- 5) Sale Management and Auctioneers are authorized by the consignor to decline any bid made by persons who have defaulted on former purchases or who in their judgement are not responsible or reliable bidders.
- 6) Any blemishes, unsoundness, defects, or irregularities of any kind as well as cribbers, parrot mouth, ridglings, and cryptorchids, must be announced before sold and Auctioneers are hereby authorized to announce such findings.
- 7) When all entries are received, sales positions will be drawn and horses will be sold in catalogue order.
- 8) Permission is hereby granted to Sales Management to edit, correct or add footnotes that are furnished.
- 9) Guest consignor's sale cost is \$60.00 per head (consignment fee) plus 7% commission on the final bid. The consignment fee must accompany this entry. Any substitutions must be owned by the original consignor. There will be a \$25.00 pass out fee for bids under \$1000.00 and a \$50.00 pass out fee for bids over \$1000.00.
- 10) **All registration certificates, transfer reports, stallion service certificates and papers must accompany horse on sale day, and must be signed by the owner or legal agents. If paperwork is not in order, the horses will be denied entry to sale facility and sale. (Photocopy of Registration Application & APHA Work Order # accepted).**
- 11) A new halter and lead shank will be **furnished by the seller** of each horse.
- 12) The Sale Committee is acting as sales intermediaries between the buyer and seller. Sales Management will not be liable for the purchase price of the horse or horses if buyer defaults, but will assist in the collection of the purchase price of the horse.
- 13) Deadline for catalogue entries is Aug 1, 2009
- 14) Payments and forms must be received before horses will be catalogued.
